CONSTRUCTION OF ROADS UNDER PMGSY

*82. SHRI OMPRAKASH BHUPALSINH ALIAS PAWAN RAJENIMBALKAR: SHRI SANJAY JADHAV:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of roads sanctioned and constructed along with the status of construction work carried out/being carried out under the Pradhan Mantri Gram Sadak Yojana (PMGSY) in the country during the last three years and the current year, State and districtwise including Osmanabad and Parbhani Parliamentary Constituency, Dadra & Nagar Haveli and Daman & diu:
- (b) whether the Government has proposed to accelerate the pace of construction of roads under the PMGSY and if so, the steps taken by the Government in this regard;
- (c) the details of cases related to delay in the construction of roads under PMGSY reported during the said period, State/UT-wise and district-wise;
- (d) whether the Government has considered the recommendations of the State Governments while selecting roads for construction under PMGSY and if so, the details thereof; and
- (e) whether the Government proposes to implement the construction of roads under this Yojana as per the recommendations of the concerned State Governments taking into consideration the rainfall and other geographical conditions of the State and if so, the details thereof?

ANSWER MINISTER OF RURAL DEVELOPMENT (SHRI GIRIRAJ SINGH)

(a) to (e) A Statement is laid on the Table of the House.

Statement referred to in reply to Parts (a) to (e) of Lok Sabha Starred Question No. *82 due for answer on 13.12.2022.

(a) The details of the road length sanctioned and constructed State-wise under various interventions of Pradhan Mantri Gram Sadak Yojana (PMGSY) during each of the last three years and current year are given in **Annexure-I**.

The district-wise and year-wise details of road length sanctioned and constructed in the country under various interventions of PMGSY may be accessed at the programme website **omms.nic.in=>progress monitoring=>Financial Year wise Achievement.** Road wise status may be accessed at the programme website **omms.nic.in=>proposal=> statewise list of roads.**

Parliamentary Constituency wise details are not maintained in the Ministry. Osmanabad parliamentary constituency comprises parts of Latur, Osmanabad and Solapur districts and Parbhani parliamentary constituency comprises parts of Jalna and Parbhani districts. Details of road length sanctioned and constructed in these districts during each of the last three years and the current year (till 07.12.2022) are given as under.

Union Territories of Dadar Nagar Haveli and Daman & Diu have not submitted project proposals for sanction under PMGSY.

- (b) The progress under the programme is monitored at regular intervals by way of Regional Review Meetings (RRMs), Performance Review Committee (PRC) Meetings and Pre-Empowered/ Empowered Committee Meetings with the States. In addition to this, senior officers of the Ministry review the progress with senior officers of the state, through meetings and visits. Review is also done by the Minister with the states.
- (c) 'Rural road' is a State Subject and construction of roads is the responsibility of the State Governments. Challenges such as land acquisition, forest clearance, poor contracting capacity impacted the overall progress. In the North-Eastern and hill states, some additional issues like adverse climate conditions, tough terrain, short working season etc., also came in the way which compounded the delay in the construction of roads under PMGSY.

The timeline for completion of PMGSY-I was earlier till March 2019 and that of PMGST-II and Road Connectivity Project for Left Wing Extremism Areas (RCPLWEA), till March 2020. Due to the above factors and request of the states, the timeline for PMGSY-I & II was extended upto September 2022 and for RCPLWEA upto March 2023. Timeline for completion of PMGSY-III is till March 2025.

The details of the balance projects of PMGSY-I as on 31st March 2019 are given in **Annexure-II** and the details of balance projects of PMGSY-II and RCPLWEA as on 31st March 2020 are given in **Annexure-III**.

The details of the balance projects of PMGSY-I and II as on 30th September 2022 are given in **Annexure-IV & V** respectively.

District wise and year wise details of balance projects of PMGSY-I, PMGSY-II and RCPLWEA may be accessed at the programme website **omms.nic.in=> progress monitoring=> State MPR abstract report.**

- (d) The projects under PMGSY are sanctioned based on the project proposals submitted by the respective State Governments/ UTs. The selection of roads is done by the State Governments in terms of the provision of the programme guidelines and with due consultation with Public Representatives. The project proposals are prepared by Programme Implementation Units (PIUs) in the States and these are approved by the District Panchayats, State Rural Road Development Agency (SRRDA) and State Level Standing Committee (SLSC) before being forwarded to the Central Government for approval.
- (e) Rural roads under PMGSY are constructed and maintained as per the technical specifications of Manual of Rural Roads and Indian Roads Congress (IRC) specifications. Specifications prescribed in these Codes & Manuals take into consideration specific geographic and topographical parameters.
