PM-KISAN BENEFICIARIES IN WEST BENGAL

1017. SHRI ADHIKARI DEEPAK(DEV):

Will the Minister of Agriculture and Farmers Welfare कृषि एवं किसान कल्याण मंत्री be pleased to state:

(a) the details of Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) Yojana and the number of Kisans who get the benefits of the said scheme in February, 2019, State-wise;

(b) the total number of farmers who get the benefit of the said Yojana in June, 2022 installment, State-wise; and

(c) the details of beneficiaries in the State of West Bengal from February, 2019 to June, 2022?

ANSWER

कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) The Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) is a Central Sector Scheme being implemented since 1st December, 2018. The Scheme aims at providing financial assistance to landholding farmer families across the country, subject to certain exclusion criteria, to enable them to take care of expenses related to agriculture and allied activities as well as domestic needs. Under the Scheme, an amount of Rs. 6000/- per year is transferred in three 4-monthly installments of Rs.2000/- directly into the bank accounts of the farmers.

States/UTs identify and verify the beneficiaries under the PM-KISAN Scheme. Beneficiaries are entitled to receive benefits of the Scheme from the 4-monthly period in which they are registered under the Scheme. Benefits are transferred to the beneficiaries through Direct Benefit Transfer mode on the basis of verified data received from the States/UTs on the PM-KISAN Portal. To help the States/UTs for automated

validation of the beneficiaries' data, PM-KISAN portal has been integrated with the portals of Unique Identification Authority of India (UIDAI) for Aadhaar authentication; with Public Finance Management System (PFMS) for validation of account and Central Government pensioners data; with Income Tax Department for validation of income tax payee status; and with National Payment Corporation of India (NPCI) for validation of Aadhaar based payments. Details of number of Kisans who got benefits of the scheme during the period December, 2018 to March, 2019, State-wise is placed at Annexure I.

(b) The total number of farmers who got the benefit of the said Yojana during the period April to July 2022, State-wise is also placed at Annexure I.

(c) The State of West Bengal on boarded the PM-KISAN Scheme from 8th period onwards. The details of beneficiaries in the State of West Bengal from February, 2019 to June, 2022 is placed at Annexure II.
