START-UP VILLAGE ENTREPRENEURSHIP PROGRAMME

1064. SHRI KURUVA GORANTLA MADHAV: SHRI VISHNU DATT SHARMA:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the salient features of the Start-up Village Entrepreneurship Programme (SVEP);
- (b) whether SVEP is being implemented in the country;
- (c) if so, the details thereof, State and districtwise particularly in Andhra Pradesh and Madhya Pradesh;
- (d) if not, the reasons therefor;
- (e) the number of village entrepreneurs who have been supported to set up local enterprises and the details of rural entrepreneurs who have been provided finance along with employment generated, State and district-wise, particularly in Panna, Chhatarpur and Katni districts of Madhya Pradesh and Andhra Pradesh; and
- (f) the other benefits which have been proposed or planned under the Scheme, if any, so as to expand its reach to more rural youth?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a) Start-up Village Entrepreneurship Programme (SVEP), the sub-scheme under Deendayal Antyodaya Yojana National Rural Livelihoods Mission (DAY-NRLM) has the objective of helping members of Self Help Groups (SHGs) or their family members to set-up small enterprises in the non-farm sector. The salient features of the programme are:
 - 1. SVEP aims to support rural entrepreneurs by developing an eco-system for supporting small businesses in rural areas. The block is the unit of implementation of SVEP.
 - 2. The eco-system comprises of a cadre of Community Resource Person Enterprise Promotion (CRP-EP) who will provide business support services to entrepreneurs.
 - 3. A dedicated fund called Community Enterprise Fund (CEF) is set-up to provide seed capital for enterprises.
 - 4. A Block Resource Centre (BRC), the dedicated centre at the block level for supporting enterprise promotion is established in each SVEP block.
 - 5. An exclusive team comprising of block anchors, mentors and Block Programme Managers (BPM) SVEP at the block level with a clear understanding of business dynamics and entrepreneurship helps in implementing SVEP.
 - 6. The maximum budget for one SVEP block is ₹ 6.50 Cr (Central and State Share). The project duration for SVEP is for a period of 4 years from the approval of Detailed project report (DPR).
- (b) SVEP is a demand based sub scheme of DAY-NRLM and there is no specific allocation for any State/UT. States/UTs submit the supplementary AAP for approval of SVEP

Blocks. These AAPs are evaluated as per the scheme guidelines and presented to Empowered Committee (EC) for consideration. The SVEP programme is being implemented across 29 States/UTs in the country.

- (c) Total no. of SVEP Blocks approved in 29 States/UTs and district-wise particularly in Andhra Pradesh and Madhya Pradesh are attached at Annexure-I in table 1 and table 2.
- (d) Does not arise
- (e) The number of village entrepreneurs who have been supported to set up local enterprises and the details of rural entrepreneurs who have been provided finance along with employment generated, State and district-wise and details of SVEP blocks in Madhya Pradesh and Andhra Pradesh is attached at Annexure-II in table 1 and table 2. In Panna, Chhatarpur and Katni districts of Madhya Pradesh, no enterprises have been set up under SVEP.
- (f) No other benefits are planned under the SVEP scheme .
