#### **PMAY-G IN HARYANA**

#### 1149. SHRIMATI SUNITA DUGGAL:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the total number of beneficiaries registered and houses built/under construction under Pradhan Mantri Awas Yojana-Gramin (PMAY-G) in the State of Haryana, district-wise including Sirsa district during the last three years and the current year;
- (b) the total number of houses handed over to beneficiaries in the Parliamentary Constituency of Sirsa during the said period, district-wise;
- (c) the total amount of funds approved and released by the Union Government to build houses under PMAY-G in the State of Haryana, district-wise during the said period; and
- (d) whether the Government has any proposal to increase local resources in construction of houses under PMAY-G and if so, the details thereof?

#### **ANSWER**

## MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a) The Statement reflecting the total number of beneficiaries registered and houses built/under construction under Pradhan Mantri Awas Yojana-Gramin (PMAY-G) in the State of Haryana, district-wise including Sirsa district during the last three years and the current year is given at Annexure.
- (b) The total number of houses completed under PMAY-G in the Parliamentary Constituency of Sirsa during the last three years and current, district-wise is as under:

- (c) Under PMAY-G during the period 2019-20 to 2022-23, a total central share of Rs. 49.29 crore has been released to the State of Haryana. These funds are released directly to the State/UT considering the State/UT as a unit. Further release of these funds to beneficiaries in various districts is done by the respect State/UT Governments.
- (d) Under PMAY-G, the beneficiaries are being assisted in house construction with a bouquet of house design typologies inclusive of disaster-resilient features that are suitable to their **local geo-climatic conditions**. Steps being taken by the Ministry of Rural Development (MoRD) to increase local resources in construction of houses under PMAY-G are given below –

- i. MoRD with the help of IIT-Delhi, United Nations Development Programme (UNDP), and CSIR-Central Building Research Institute (CSIR-CBRI) undertook state-specific studies in 18 states for the development of house design typologies appropriate to local geo-climatic and cultural context with the disaster-resilient feature. As an outcome of the study, the Ministry published a compendium of region-specific house designs with the name 'Pahal' which includes 108 house designs for 62 housing zones in 15 States in the country.
- ii. Encouraged to construct demonstration houses on region-specific house design typologies for PMAY-G beneficiaries to visit, experience and opt for.
