BUDGETARY ALLOCATION AND UTILIZATION FOR BHARATNET

SHRI VIJAY BAGHEL:

Will the Minister of COMMUNICATIONS be pleased to state:

- (a) the details of budgetary allocation and utilization for BharatNet project at present, State/UT-wise including in Bilaspur, Durg and Chatra Parliamentary Constituencies;
- (b) whether it is a fact that BharatNet project has connected all the Gram Panchayats (GPs) of the country with high-speed optical fibre cable network and optimal mix of media i.e. optical fibre cable/radio/satellite therein;
- (c) if so, the details thereof and if not, the reasons therefor;
- (d) the number of GPs including in Bilaspur, Mungeli, Gaurela-Pendra-Marwahi districts of Chhattisgarh, Chatra and Latehar, Durg and Bemetara districts of Jharkhand, which have been connected with optical fibre cable/radio/satellite, at present, State/UT-wise thereto; and
- (e) the steps being taken by the Government to improve the broadband connectivity with Gram Panchayats?

ANSWER MINISTER OF STATE FOR COMMUNICATIONS (SHRI DEVUSINH CHAUHAN)

- (a) The State/UT-wise details of budgetary allocation / utilisation/ disbursement of Funds for BharatNet project upto September 2022, including Bilaspur, Durg and Chatra Parliamentary Constituencies is given in **Annexure-I.**
- (b) & (c) On 19.07.2017, Union Cabinet approved the BharatNet project to provide broadband connectivity to approximately 2.6 lakh Gram Panchayats (GPs) in the country out of which 1,84,399 GPs have been made service ready. BharatNet is a challenging project of mega nature as the Gram Panchayats (GPs) are widely dispersed across the country in rural and remote areas. The reason for delay in the implementation of the BharatNet are as under:

- 1. Delay in project implementation because of multiple challenges in remote and far-flung rural areas, involvement of multiple agencies, and slow progress by implementing agencies.
- 2. Delay in Right of Way clearances from Government Instrumentalities regulating forest land, railway lines, defense areas, highways, oil and gas pipelines or any other agencies or departments.
- (d) The States/UT wise detail of Gram Panchayats which have been made Service Ready on optical fibre cable/radio/satellite under the BharatNet Project is given in **Annexure-II.**

The number of Gram Panchayats in Bilaspur, Mungeli, Gaurela-Pendra-Marwahi Durg and Bemetara Districts of Chhattisgarh, Latehar and Chatra Districts of Jharkhand, which have been connected with optical fibre cable/radio/satellite is as given below:
