(a) & (b): Ministry of Textiles has been providing subsidy support to textile industry, including Micro, Small and Medium Enterprises (MSMEs) and small textile manufacturing units across the country through Pan-India schemes such as Amended Technology Upgradation Fund Scheme (ATUFS) and Powertex India. Details of support provided under the schemes are given in Annexure-I.

(c): Details of textile units in Rajasthan provided support under ATUFS and Powertex India Scheme are given in Annexure-II.
