QUANTUM OF TEXTILE EXPORTS

1280. SHRI DUSHYANT SINGH:

Will the Minister of TEXTILES वस्त्र मंत्री  
be pleased to state :

- (a) the details of the quantum of textiles exported and the earnings generated from such exports for the past three years, year-wise and State-wise;
- (b) whether it is a fact that exports of cotton yarn and handloom products registered a 40% slump in September compared to last year;
- (c) if so, the details thereof and if not, the actual year over year (y-o-y) difference in export quantities;
- (d) whether there has been a fall in RoSCTL textile exports since the Union Government announced the provision of issue of rebate under RoSCTL was to be implemented in the form of freely transferable duty credit scrips against cash under the earlier system;
- (e) if so, the details thereof including the revenue lost by the Government and if not, the reasons therefor; and
- (f) whether the Government plans to expand the usage of RoSCTL scrips beyond payment of BCD to other levies to decrease demand for scrips and if so, the details thereof?

**(b) & (c):** The earlier shortage of cotton had resulted in lesser availability and higher price of cotton yarn which affected its export along with the export of handloom products.

**(d) & (e):** Exports of Textiles covered under RoSCTL scheme has grown 6% in Rupee terms since the inception of scheme [FY 2019-20, 2020-21, 2021-22 & 2022-23(April-September)] against the earlier 3.5 years [FY 2015-16, 2016-17, 2017-18 & 2018-19 (April-September)].

**(f):** There is no such proposal in the Ministry.
