- (b) whether the Government has received any request from the States for the issue of additional ration;
- (c) if so, the details thereof, State-wise and the ration sanctioned by the Union Government; and
- (d) the details of amount of foodgrains lifted and distributed by each State under PMGKAY?

- (a): The Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) has been implemented in all 36 States/UTs. Details of foodgrains allocated by States/UTs under PMGKAY are at Annexure-I.
- (b) and (c): All States/UTs have been allocated foodgrains as per their entitlements under National Food Security Act (NFSA) / (PMGKAY). Any request for additional allocation of foodgrains over and above NFSA/PMGKAY, is processed in accordance with extant instructions.
- (d) Details of foodgrains lifted and distributed by States/UTs under PMGKAY are at Annexure-II.
