(a) & (b): Yes, Sir. State-wise details of number and capacity of warehouse constructed during the last three year i.e. F.Y. 2019-20, 2020-21, 2021-22 and upto Nov'22 by Food Corporation of India (FCI) are Annexed.

(c) & (d): Yes, Sir. The details are as given below:-

(e) & (f): Yes, Sir. As on 01.11.2022, a quantity of 32.21 LMT of stock (FCI: 23.96 LMT & State Agencies: 8.25 LMT) is stored against the available covered storage capacity of 85.39 Lakh MT available with FCI (53.06 LMT) and State agencies (32.33 LMT) for Central Pool.
