TEXTILE TRAINING CENTRES

Will the Minister of TEXTILES वस्त्र मंत्री be pleased to state :

- (a) the number of textile training centres which have been registered and functioning across the country including Tamil Nadu at present;
- (b) whether more such centres are proposed to be set up in the country;
- (c) if so, the details thereof;
- (d) whether any proposal has been received in this regard from Tamil Nadu, if so, the details thereof and the action taken thereon:
- (e) whether the Government has partnered with Government agencies from various States and sectoral organizations for entry level training and job creation in both traditional and organized segments of textile value chain; and
- (f) if so, the details thereof, State-wise especially in the State of Tamil Nadu?

उत्तर ANSWER वस्त्र राज्य मंत्री (**श्रीमती दर्शना जरदोश**) THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

- (a) to (c): This Ministry is implementing various Textiles sector schemes/programmes and conducts textiles training activities in partnership with training institutes, industry partners, State Governments by providing them necessary support for operational and technical requirements. Under the umbrella skilling scheme of Samarth, a total of 1,537 registered training centres are functioning across the country which includes 400 centres in Tamil Nadu. The institutional capacities of Weavers Service Centres, Handicraft Service Centres, Powerloom Service Centres, Sericulture Institutions, and Textile Research Associations are also utilized for training purposes. Opening of training centres under various schemes is need based and demand driven.
- (d): A proposal was received from Directorate of Handlooms and Textiles, Govt. of Tamil Nadu for allocation of training target under Samarth. The State agency has been allocated a target of 1400 beneficiaries.
- (e) & (f): The Ministry of Textiles has allocated training target to State Government Agencies from various States and Sectoral Organizations of Ministry of Textiles for entry level training and job creation in both traditional and organized segments of textile value chain. Details are given at Annexure-I.
