PENDING IRRIGATION PROJECTS IN ODISHA

Will the Minister of JAL SHAKTI be pleased to state:-

- (a) the name and the number of medium, multipurpose and major projects to be executed in the State of Odisha which are pending for the approval of Central Water Commission (CWC);
- (b) the total hectares of land to be brought under irrigation once each of these projects is completed;
- (c) the estimated cost of these projects;
- (d) the funds earmarked for these projects and the funds released so far;
- (e) the steps taken to expedite the clearance; and
- (f) the present status of each of these projects?

ANSWER

THE MINISTER OF STATE FOR JAL SHAKTI (SHRI BISHWESWAR TUDU)

- (a) to (d) As per the information provided by the Central Water Commission (CWC), there are two major/multi-purpose and four medium irrigation projects of Odisha currently under appraisal in CWC. The details of these projects including area to be irrigated under these projects, their estimated cost and their present status etc. are given at Annexure.
- (e) and (f) Completion of appraisal process depends on the submission of compliances by the project authorities on the observations of CWC and other Central Government agencies on various aspects like hydrology, irrigation planning, inter-State aspects, design, cost estimation etc. in a reasonable time frame. Consequent upon the completion of the appraisal process, the projects are considered by the Advisory Committee of the Department of Water Resources, River Development & Ganga Rejuvenation for its approval in respect of Detailed Project Reports (DPRs).
