FUNDS UNDER JJM IN UP

1414. SHRI JAGDAMBIKA PAL

Will the Minister of JAL SHAKTI be pleased to state:-

- (a) the details of the funds sanctioned and released by the Government under Jal Jeevan Mission (JJM) in the State of Uttar Pradesh since 2017, year-wise;
- (b) whether the percentage of pipe/tap water connections has increased, especially for the said State:
- (c) if so, the details thereof and if not, the reasons therefor;
- (d) the time by which all rural households would get pipe water connections in the said State;
- (e) whether the Government proposes to implement similar scheme in the urban areas; and
- (f) if so, the details thereof and if not, the reasons therefor?

ANSWER

(a) Since August 2019, Jal Jeevan Mission (JJM), a centrally sponsored scheme, is being implemented in partnership with States, to make provision of potable tap water supply to every rural household of the country on regular and long-term basis, by 2024. Prior to the JJM, the Government was implementing National Rural Drinking Water Programme (NRDWP) for piped drinking water supply in rural areas of States/ UTs. The details of funds released to the State under JJM & NRDWP are as under:

- (b) to (d) Yes. On 15th August, 2019, at the time of announcement of Jal Jeevan Mission, 3.23 Crore households were reported to have tap water connections. Since then, additional 7.45 Crore rural households have been provided with tap water connections. Thus, as on 09.12.2022, out of 19.36 Crore rural households in the country, 10.68 Crore (55.20%) households have provision of tap water supply in their homes. Similarly, in Uttar Pradesh, at the launch of JJM, 5.16 Lakh rural households were having provision of tap water connection. Since then, additional 54.42 Lakh rural households have been provided tap water connection in the State. Till 09.12.2022, out of 264.41 Lakh rural households in the State, 59.58 Lakh (22.53%) households have provision of tap water supply in their homes. The remaining households in the country including those in Uttar Pradesh, are planned to be covered by 2024.
- (e) & (f) As informed by Ministry of Housing and Urban Affairs (MoHUA), Government of India has launched AMRUT 2.0 on 01st October, 2021 for the period of 05 years (FY 2021-22 to 2025-26), with the objective of providing universal coverage of tap water supply to households through functional household tap connections in all statutory towns in the country.
