**(a): Ministry of Housing and Urban Affairs (MoHUA) has launched Prime Minister Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) Scheme on June 01, 2020 with the aim to facilitate collateral free working capital loan to street vendors to restart their businesses, which were adversely impacted during the COVID-19 pandemic. The scheme has the following objectives;**

- i. Facilitate collateral free working capital loan upto ₹10,000, of 1 year tenure, with enhanced loan of ₹20,000 and ₹50,000 in the second and third tranches respectively, on repayments of earlier loans.**
- ii. Incentivize regular repayment, through interest subsidy @ 7% per annum; and**
- iii. Reward digital transactions, by way of cash back upto ₹1,200 per year.**

**(b): A statement showing number of beneficiaries, ULB & District-wise in the State of Karnataka, as on December 05, 2022 is at Annexure- I.**

**(c): The details of amount sanctioned and disbursed, State-wise under the scheme is at Annexure-II.**

**(d): Yes, Sir. The PM SVANidhi Scheme has been allocated a total budget of Rs. 2096.49 Cr. from 2020-21 to 2027-28.**
