### MSME IN JAMMU & KASHMIR

## 1507. SHRI JUGAL KISHORE SHARMA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of Micro, Small and Medium Enterprises (MSMEs) schemes being implemented in Jammu & Kashmir at present;
- (b) the details of the beneficiaries during the last three years, district-wise; and
- (c) the details of the funds allocated and released for various MSME schemes in Jammu & Kashmir during the said period?

#### **ANSWER**

# MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

(a): Ministry of MSME implements various schemes/programmes for the promotion and development of Micro, Small and Medium Enterprises (MSMEs) sector across the country including Jammu & Kashmir which inter alia include Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Credit Guarantee Scheme for Micro and Small Enterprises (CGTMSE), A Scheme for Promoting Innovation, Rural Industry & Entrepreneurship (ASPIRE).

The Government has taken a number of recent initiatives to support MSMEs in the country including Jammu & Kashmir, which inter alia include;

- (i) Rs. 5 lakh crore Collateral Free Automatic Loans for business, including MSMEs.
- (ii) Rs. 50,000 crore equity infusion through MSME Self-Reliant India Fund.
- (iii) New revised criteria for classification of MSMEs.
- (iv) No global tenders for procurement up to Rs. 200 crores.
- (v) "Udyam Registration" for MSMEs, for Ease of Doing Business.
- (vi) Launching of an online Portal "Champions" in June, 2020 to cover many aspects of egovernance including grievance redress and handholding of MSMEs.
- (vii) Inclusion of Retail and Wholesale trades as MSMEs w.e.f. 02<sup>nd</sup> July, 2021.
- (viii) Non-tax benefits extended for 3 years in case of an upward change in status of MSMEs.
- (b): District-wise beneficiaries in Jammu & Kashmir during the last three years under major schemes of the Ministry such as PMEGP and CGTMSE are given at Annexure-I and Annexure-II, respectively. District-wise number of MSMEs registered on the 'Udyam Registration' portal in Jammu & Kashmir are given at Annexure-III.
- (c): Schemes of the Ministry of MSME are Central Sector Schemes where funds are not allocated State/UT-wise.
