- (a) whether Government has failed to implement central schemes for welfare of women and children in the country particularly in Tamil Nadu and Maharashtra, if so, the details thereof and the reasons therefor;
- (b) the quantum of amount released and utilized under central schemes for the welfare of women and children during each of the last three years;
- (c) whether several NGOs seeking financial assistance for implementing these schemes have been found to be fake and if so, the details thereof along with the measures taken by Government to check credential of such NGOs and the criteria/ parameter adopted to grant assistance to them;
- (d) whether the Government has put any mechanism in place to ensure effective implementation of the said schemes and if so, the details thereof and if not, reasons therefor; and
- (e) whether Government is planning to involve celebrities for endorsement of these schemes, if so, the details thereof?

(a) to (d) To ensure efficient implementation and better monitoring, all the schemes implemented by the Ministry for women and children in the country, including in the States of Tamil Nadu and Maharashtra, have been organised into three verticals, viz.

(1) 'Saksham Anganwadi & Poshan 2.0' for Nutrition Support for Children, Adolescent Girls and Pregnant Women & Lactating Mothers; and for Early Childhood Care & Education (2) 'Mission Shakti' for safety, security and empowerment of women (3) 'Mission Vatsalya' for protection and welfare of children.

The quantum of amount released and utilized under the schemes for welfare of women and children viz. Mission Saksham Anganwadi & Poshan 2.0; Mission Shakti: and Mission Vatsalya, during each of the last three years is **annexed**.

All the schemes of the Ministry are being implemented through the State/UT Governments. The Ministry does not sanction funds to NGOs.
