- (a) whether the Government has taken cognizance of the shortage of various fertilizer being faced by farmers in various districts of Tamil Nadu;
- (b) if so, the steps taken by the Government so far to tackle such issue;
- (c) the details of different fertilizers allocated to the State of Tamil Nadu along with the quantities disbursed so far;
- (d) whether the Government has enough stock of fertilizers to deal with pan India demands for the upcoming crop season;
- (e) if so, the details thereof along with the allocations made to different States for the upcoming crop season; and
- (f) the time by which the Government plan to release such fertilizers to the States?

- (a) & (b): The availability of fertilizers have remained comfortable in the State of Tamil Nadu.

Further, before the commencement of each cropping season, Department of Agriculture and Farmers Welfare (DA&FW), in consultation with all the State Governments, assesses the state-wise & month-wise requirement of fertilizers.

- 1. On the basis of requirement projected, Department of Fertilizers allocates sufficient/ adequate quantities of fertilizers to States by issuing monthly supply plan and continuously monitors the availability.
- 2. The State Governments are regularly advised to coordinate with manufacturers and importers of fertilizers for streamlining the supplies through timely placement of indents for railway rakes through their state institutional agencies like Markfed etc.
- Regular Weekly Video Conference is conducted jointly by DA&FW and DoF with State Agriculture Officials and corrective actions are taken to dispatch fertilizer as indicated by the State Governments.
- 4. The gap between demand (requirement) and production for Urea & other fertilizer is met through imports. The import for the season is also finalised well in advance to ensure timely availability.
