#### PRADHAN MANTRI MATRU VANDANA YOJANA

1750. SHRIMATI BHAVANA PUNDALIKRAO GAWALI: SHRIMATI DELKAR KALABEN MOHANBHAI:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) since when the Pradhan Mantri Matru Vandana Yojana and Ready Meal Scheme are being implemented in Maharashtra and Dadra and Nagar Haveli and Daman and Diu:
- (b) the details of funds provided and ration supplied particularly to Dadra and Nagar Haveli and Daman and Diu since the schemes have been launched, year-wise, district-wise and Anganwadi-wise;
- (c) whether any guidelines/orders/instructions have been issued by the Union Government to the State for implementation of the schemes, if so, the details thereof:
- (d) whether the Government has received complaints regarding rampant irregularities being committed in the said schemes; and
- (e) if so, the details thereof and the steps taken by the Government in this regard?

### **ANSWER**

## MINISTER FOR WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

- (a) The Government is implementing Pradhan Mantri Matru Vandana Yojana (PMMVY) w.e.f. 01.01.2017 across the country, including the State of Maharashtra and Union Territory of Dadra & Nagar Haveli and Daman & Diu.
- (b) The funds under PMMVY are released State/UT-wise. Thus, the Government does not maintain District-wise and Anganwadi Centre-wise amount of funds released under PMMVY. The Year-wise details of funds released under PMMVY to the Union Territory Administration of Dadra & Nagar Haveli and Daman & Diu since inception of the scheme and till 13.12.2022 is as under:

2018-19	1.05
2019-20	2.51
2020-21	0.34
2021-22	1.71
2022-23	1.48

There is no "Ready Meal Scheme" being implemented by Union government

- (c) The Ministry has conveyed approval of the Pan-India implementation of PMMVY to all States/Union Territories vide letter dated 19.05.2017. The Scheme Implementation Guidelines of PMMVY were issued on 01.09.2017. The Mission Shakti Scheme Guidelines, of which PMMVY is a component, were issued on 14.07.2022.
- (d) & (e) As PMMVY is implemented through State Governments/UT Administrations, complaints regarding implementation are referred to the concerned State Government/UT Administration for taking appropriate remedial action.
