INCOME CRITERIA FOR AYUSHMAN BHARAT YOJANA

1793. SHRI RATTAN LAL KATARIA:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether the benefits of Ayushman Bharat Yojana is fixed on the basis of SECC data of 2011 bythe Government and if so, the details thereof;
- (b) whether any condition regarding annual income has been fixed to extend the benefit of the Yojana and if so, the details thereof;
- (c) whether some States have increased the limit of annual income for availing benefits of the Yojana and if so, the details thereof, State/UT-wise;
- (d) whether the number of Ayushman beneficiaries have increased as a result thereof and if so, the details thereof, State/UT-wise; and
- (e) whether the income of some families have increased more than the fixed amount during the last eleven years after finalisation of Ayushman Bharat Yojana on the basis of SECC data of 2011 and if so, whether the Government proposes to extend its benefit to the new beneficiaries?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (e): Ayushman Bharat – Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) launched on 23.09.2018 is the world's largest insurance/assurance scheme. The scheme provides health coverage of Rs. 5 lakh per beneficiary family per annum to approximately 10.74 crore poor and vulnerable families identified on the basis of select deprivation and occupational criteria in rural and urban areas respectively as per SECC database of 2011. Beneficiary database is defined under the scheme. States/UTs may, however, implement their own health protection schemes in alliance with AB-PMJAY at their own cost. Accordingly, States/UTs have expanded the coverage of the scheme to 14.77 crore beneficiary families. State/UT-wise details thereof are at Annexure.

Ministry of Health & Family Welfare has issued instructions to States/UTs on 23.06.2022 tomake use of their own datasets for identification of beneficiaries. For this purpose, only poor, deprived and marginalized families may be enrolled, keeping the overall design and intent of AB-PMJAY scheme intact. Government of India shall, however, provide its share of funding for all such beneficiaries limited to the number of eligible households as per SECC 2011 database.
