E-SHRAM PORTAL REGISTRATION IN ASSAM

1909. SHRI KRIPANATH MALLAH:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the salient features of e-Shram portal;**
- (b) the details of the number of unorganized workers registered under this portal within Assam so far;**
- (c) the steps taken to increase the number of registrations of unorganized workers on the e-Shram portal to maximize the impact of the benefits that can be availed by these workers in the unorganized sector;**
- (d) the details of funds allocated, sanctioned and disbursed during the last five years for the development of the portal; and**
- (e) whether any steps have been taken to improve the participation of women in labour force both in urban and rural areas, if so, the details thereof and if not, the reasons therefor?**

ANSWER

(a) to (e): Ministry of Labour & Employment has launched e-SHRAM portal, a National Database of the Unorganised Workers seeded with Aadhaar on 26th August, 2021. It has been made available to the States/UTs for registration of unorganised workers on e-SHRAM portal. The main objectives of the portal are to maintain a dynamic database of workers, provide universal account number (UAN), facilitate delivery of social security and welfare benefits, ensure portability of benefits, opportunities for job search and skill development by linkages to NCS, ASEEM & UDYAM portals.

As on 13.12.2022, the number of unorganised workers registered under this portal within Assam is 68, 57,867. Registration on e-SHRAM portal is completely free and on self-declaration basis.

To increase the number of registrations, the matter is taken up with all the States/UTs from time to time. The registration facility is available at over 4 lakh CSC centres across the country. State Seva Kendras have also been on boarded. Further, CSC organises awareness camps (including night camps) at various places for mobilisation of workers. e-SHRAM portal has also been on boarded on UMANG App for easy registration through mobile.

Rs. 45.39 crore has been sanctioned/disbursed during 2020-21 for development and maintenance of eSHRAM portal.

Government has taken various steps to improve women's participation in the labour force and quality of their employment. A number of protective provisions have been incorporated in the labour laws for equal opportunity and congenial work environment for women workers. These include enhancement in paid maternity leave from 12 weeks to 26 weeks, provision for mandatory creche facility in the establishments having 50 or more employees, permitting women workers in the night shifts with adequate safety measures, etc.

Government has taken a decision to allow the employment of women in the aboveground mines including opencast workings between 7 pm and 6 am and in below ground working between 6 am and 7 pm in technical, supervisory and managerial work where continuous presence may not be required.

The Equal Remuneration Act, 1976 now subsumed in the Code on Wages, 2019 which provides that there shall be no discrimination in an establishment or any unit thereof among employees on the ground of gender in matters relating to wages by the same employer, in respect of the same work or work of similar nature done by any employee. Further, no employer shall make any discrimination on the ground of gender while recruiting any employee for the same work or work of similar nature in the conditions of employment, except where the employment of women in such work is prohibited or restricted by or under any law for the time being in force.

Further, in order to enhance the employability of female workers, the Government is providing training to them through a network of Women Industrial Training institutes, National Vocational Training Institutes and Regional Vocational Training Institutes.

As on 13.12.2022, more than 28.46 crore unorganised workers have been registered on eSHRAM portal. Out of which 52.81% are female workers and 47.19% are male workers.
