- (b) to (d): Ministry of Tourism, Government of India under its Schemes of Swadesh Darshan, PRASHAD and Assistance to Central financial assistance Agencies. provides central to State Governments/Union Territories/Central Agencies for development of tourism related infrastructure and facilities to provide an enriching tourism experience to visitors in a planned and phased manner. This is continuous process. The projects under the Schemes are identified for development in consultation with State Governments/Union Territory (UT) Administrations and are sanctioned subject to availability of funds, submission of suitable detailed project reports, adherence to scheme guidelines and utilization of funds released earlier.

The details of project sanctioned under Swadesh Darshan scheme, PRASHAD scheme and Scheme of Assistance to Central

Agencies for Tourism Infrastructure and their current status are given at Annexure. The projects sanctioned in Uttar Pradesh are at various stages of implementation/completion. Till now, no projects have been resulted in cost escalation.

Ministry of Tourism is also promoting varied tourist destinations and products including heritage sites under the Incredible India branding in the international and domestic markets for drawing more tourists to visit these sites in the country and providing necessary momentum for creation of employment opportunities for the local people and development of economy in the State/UT.
