ATAL PENSION YOJANA

1954. Shri Rajeshbhai Chudasama, Shrimati Poonam Mahajan

Will the Minister of Finance be pleased to state:

- (a) the funds transferred under Atal Pension Yojana during the last five years, State-wise;
- (b) the beneficiaries under this scheme during the said period, State-wise;
- (c) the beneficiaries from SC/ST community under this scheme during the said period, Statewise;
- (d) the women beneficiaries under this scheme during the same period, State-wise; and
- (e) the beneficiaries from transgender community under this scheme during the said period, State-wise?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (DR. BHAGWAT KARAD)

- (a) The Atal Pension Yojana (APY) is a Government of India scheme launched on 9th May, 2015, with the objective of creating a universal social security system for all Indians, especially the poor, the under-privileged and the workers in the unorganised sector. It is open to all citizens of India between 18-40 years of age having a savings bank account in a bank or post-office. For better targeting of guaranteed pension to unorganised sector workers, an income tax payer shall not be eligible to join APY from 1st October, 2022. The subscriber under APY is required to make a monthly/quarterly/six monthly contribution of an amount determined by the amount of pension chosen and the age of joining the scheme. The subscriber shall receive a government guaranteed minimum pension of Rs. 1000 per month, Rs. 2000 per month, Rs. 3000 per month, Rs. 4000 per month or Rs. 5000 per month, after the age of 60 years until death, depending on the contribution chosen.
- (b) to (e) The scheme is open to all eligible citizens of India. As informed by PFRDA, the details of whether the subscriber is from SC/ST community are not captured during the enrolment process under APY. The financial year wise details of State-wise enrolments, women enrolled, and enrolments from transgender community under APY during the period 2018-19 to 2022-23 (up to 30th November, 2022), are annexed at Annexure A, Annexure B, and Annexure C respectively.
