Allocation of Funds for Fisheries, Animal Husbandry and Dairying

Will the Minister of **FISHERIES, ANIMAL HUSBANDRY AND DAIRYING**, **मत्स्यपालन पशुपालन और डेयरी मंत्री** be pleased to state:

- (a) the number of beneficiaries under various schemes of the Ministry in Telangana along with the details of the schemes related to Fisheries, Animal Husbandry and Dairying, district-wise; and
- (b) the amount of funds allocated and spent there under by the State Government of Telangana, scheme-wise?

ANSWER

(a) and (b): The Ministry of Fisheries, Animal Husbandry and Dairying, Government of India has been implementing the following schemes across the country including in the State of Telangana for development of fisheries, animal husbandry and dairy sector:

- (i) Pradhan Mantri Matsya Sampada Yojana (PMMSY),
- (ii) Fisheries and Aquaculture Infrastructure Development Fund (FIDF),
- (iii) Rashtriya Gokul Mission (RGM),
- (iv) National Livestock Mission (NLM),
- (v) National Programme for Dairy Development (NPDD),
- (vi) Animal Husbandry Infrastructure Development Fund (AHIDF),
- (vii) Livestock Health and Disease Control Programme (LHDCP) including National Animal Disease Control Programme
- (viii) Dairy Processing and Infrastructure Development Fund (DIDF),
- (ix) Supporting Dairy Cooperatives and Farmer Producer Organizations engaged in dairy activities (SDC&FPO),
- (x) Livestock Census and Integrated Sample Survey (LC & ISS)
- (xi) Assistance to State for Control of Animal Diseases (ASCAD)

The district-wise funds allocation under the various Central Sector/ Centrally Sponsored Schemes implemented by the Ministry of Fisheries, Animal Husbandry and Dairying, Government of India is decided by the concerned State Governments depending on the potential for development of fisheries, animal husbandry and dairy sectors. Details of central funds released and utilized along with beneficiaries covered under various centrally sponsored schemes as reported by the Government of Telangana are furnished below:
