SETTING UP OF NEW EV MANUFACTURING UNITS

2128. SHRIMATI CHINTA ANURADHA: SHRI MADDILA GURUMOORTHY:

Will the Minister of HEAVY INDUSTRIES भारी उद्योग मंत्री be pleased to state:

(a) whether the Government has set up new Electric Vehicle (EV) manufacturing units under National e-Mobility Programme during the last two years in Andhra Pradesh;

(b) if so, the details thereof;

(c) whether the Government is setting up more such units in other States and UTs;

(d) if so, the details thereof; and

(e) the total number of hybrid and electric vehicles manufacturing units that have been set up across the country under the programme?

ANSWER

THE MINISTER OF STATE FOR HEAVY INDUSTRIES (SHRI KRISHAN PAL GURJAR)

(a) & (b): No, Sir, the Government does not propose to set up electric vehicle manufacturing units under National e-Mobility Programme in states including Andhra Pradesh. Further, to promote manufacturing of Electric Vehicles and battery manufacturing, following two Production Linked Incentive (PLI) schemes are being implemented by the Ministry of Heavy Industries to support Automobiles and Auto Components companies including electric vehicle manufacturing companies:

- a) The Union Cabinet on 12th May, 2021 approved the Production Linked Incentive (PLI) Scheme for setting up manufacturing facilities for Advance Chemistry Cell (ACC), Battery Storage in India, with a total manufacturing capacity of 30 Giga Watt Hour (GWh) and with an outlay of Rs. 18,100 crores.
- b) Government has approved the Production Linked Incentive (PLI) Scheme for Automobile and Auto Components Industry in India for enhancing India's Manufacturing Capabilities for Advanced Automotive Products with a budgetary outlay of Rs. 25,938 crores over a period of five years.

(c) to (e): The details of electric vehicles manufacturers producing electric vehicles (e-2W, e3W and e-4W) which are registered under FAME India Scheme as on 15.12.2022 for availing demand incentive is attached as **ANNEXURE**.
