**RESTRICTION ON GLYPHOSATE**

2172. SHRI DUSHYANT SINGH

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state :-

- (a) whether the studies/reports on the basis of which Glyphosate and its derivatives have been restricted for use in the country and the rationale behind it ;
- (b) the reason why Glyphosate was restricted and not banned ;
- (c) the estimates of the increase in the cost of cultivation of farmers due to restriction of fertilizers;
- (d) the number of Pest Control Operators situated in rural agricultural areas, district wise details, thereof ;
- (e) whether any proposals have been received for label extensions for the use of Glyphosate for certain crops and if so, the basis on which such proposals would be evaluated; and
- (f) the estimate of the number of companies to return the certificate of registration granted for Glyphosate and its derivatives to the Registration Committee ?

ANSWER

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE

- (a) & (b): During February 2019, Government of Kerala prohibited the sale, distribution and use of Glyphosate and its derivatives for 60 days throughout the State of Kerala. Government of Kerala further requested to the Central Government and recommended to prohibit the sale, distribution and use of Glyphosate and its derivatives throughout the State of Kerala. The matter was examined by the subcommittee constituted by the Registration Committee. The Report of the Government of Kerala was uploaded on the website of the Directorate of Plant Protection Quarantine and Storage (DPPQ&S), Faridabad and as per the recommendations of the subcommittee and after consultation with Registration Committee and Central Insecticide Board, Central Government has published a gazette notification vide GSR 5010(E) dated 25.10.2022 for restriction on use of Glyphosate and its use to be allowed through Pest Control Operators (PCOs) only.
- (c): It is the endeavour of the Government of India to provide adequate and good quality of fertilizers to farmers. Further, Government of India promote the balanced and judicious use of fertilizers and as such has not imposed any restriction on use of any fertilizer which may lead to increase in cost of cultivation.
- (d): The State wise details of the accredited Pest Control Operators (PCOs) is attached at Annexure-I.
- (e): Proposal received for label extensions for the use of Glyphosate for cotton and grape crops and their evaluation is done as per the guidelines of Registration Committee.
- (f): Companies are not to return their Certificate of Registration granted for Glyphosate and its derivatives. Only a condition "THE USE OF GLYPHOSATE FORMULATION TO BE

ALLOWED THROUGH PEST CONTROL OPERATORS” on the label and leaflets is to be incorporated on the certificate.
