(a) & (b) **Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) -**

Under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) the Central Assistance is released to States on the basis of balance targets, committed liabilities, unspent balance available and their compliance to guidelines of the Scheme and directions received from Ministry of Finance from time to time. Details of central share released to States/UTs since 2016-17 till 2022-23 (as on 15.12.2022) under PMAY-G is given at Annexure-I.

Pradhan Mantri Awaas Yojana- Urban (PMAY-U)-

The Ministry of Housing and Urban Affairs, Government of India is implementing Pradhan Mantri Awaas Yojana-Urban (PMAY-U). A Central Assistance of ₹1.30 lakh crore has been released to States/UTs based on the compliances achieved by them in respect of sanctioned projects under PMAY-U. The details of the same are given at Annexure-II.
