ALLOCATION OF FUNDS UNDER PMFME

2218. SHRI JAYANT SINHA:

Will the MINISTER OF *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the total funds allocated and utilized to support individual micro-enterprises under the PM Formalization of Micro Food Processing Enterprises (PMFME) Scheme since inception;
- (b) the number and type of the afore-mentioned micro-enterprises, State-wise;
- (c) the number and type of the afore-mentioned micro-enterprises, district-wise in Jharkhand; and
- (d) the nature and period of training support provided to the micro-enterprises under the Scheme?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI PRAHLAD SINGH PATEL)

(a). The total funds allocated under PMFME Scheme is Rs. 1089 crore till date, out of which Rs. 868.33 crore has been utilized since inception.

(b). Till date, Centre share of grants-in-aid has been released to 4,667 micro enterprises in 32 States / UTs as per **Annexure**. Organizations such as Individual entrepreneurs/ Proprietorship Firms/ Partnership Firms/ Farmer Producer Organizations(FPOs)/ NGOs/ Cooperatives/ SHGs/ Pvt. Ltd. Companies are eligible under the Scheme.

(c). In the State of Jharkhand, no grants-in-aid has been released till date under the PMFME Scheme.

(d). The training is provided to the beneficiaries on Food Processing Entrepreneurship Development Programme for 3 days under PMFME Scheme.
