Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the objective of the Deendayal Antyodaya Yojana-National Rural Livelihood Mission (DAYNRLM) being run by the Government; and
- (b) the details and the number of awareness camps that have been organized and the business plans prepared so far on various schemes related to enterprise promotion and rural entrepreneurship across the country, particularly in Uttar Pradesh, Jharkhand, Bihar, Madhya Pradesh, Jammu and Kashmir?

ANSWER

- (a) The Government is implementing Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM) across the country(except Delhi & Chandigarh) in a mission mode with the objective of organizing the rural poor women into Self Help Groups (SHGs) and continuously nurturing and supporting them to take economic activities till they attain appreciable increase in incomes over a period of time to improve their quality of life and come out of abject poverty.
- (b) Under DAY-NRLM, the awareness of various interventions of the scheme including enterprise promotion are being done in the regular meetings of Community Based Organisations viz. Cluster Level Federations (CLFs), Village Organizations (VOs) and SHGs.

Further, Start-up Village Entrepreneurship Programme (SVEP), the sub-scheme under the Deendayal Antyodaya Yojana-National Rural Livelihoods Mission (DAY-NRLM) supports the members of Self-Help Groups (SHGs) or their family members to set-up small enterprises in the non-farm sector. The entrepreneurs are provided various types of training for running their business including skill training in identified sector, managerial training etc. The block is the unit of implementation of SVEP and it is a demand driven scheme. SVEP is approved in total 258 blocks across 29 States/UTs and Detailed Project Reports (DPRs) of 188 blocks are approved. As on 30th November, 2022 ,a total of 2,21,072 enterprises (with business plan) have been supported under SVEP. The number of SVEP DPR approved blocks and

enterprises (with business plans) supported so far in the States of Uttar Pradesh, Jharkhand, Bihar, Madhya Pradesh and Jammu & Kashmir is provided in the table below:
