- (a) the total number of industries setup in Haryana under Startup India scheme, district-wise;
- (b) the assistance provided by the banks to Startup India established in Haryana during the last three years, district-wise; and
- (c) the number of persons provided employment in Haryana under Startup India during the last three years, year-wise?

- (a): The Government with an intent to build a strong ecosystem for nurturing innovation and startups in the country launched Startup India initiative on 16th January 2016. As per eligibility conditions prescribed under G.S.R. notification 127 (E) dated 19th February 2019, entities are recognized as startups under Startup India initiative by the Department for Promotion of Industry and Internal Trade (DPIIT). 84,102 entities have been recognised as startups by the DPIIT as on 30th November 2022.

Specifically for the State of Haryana, 4,511 entities have been recognised as startups by the DPIIT since the launch of Startup India initiative in 2016 as on 30th November 2022. The district-wise and year-wise details of entities recognised as startups from the State of Haryana as on 30<sup>th</sup> November, 2022 is placed at Annexure-I.

- (b): No such data is maintained by the Government .

**(c):** The DPIIT recognised startups from the State of Haryana have self-reported to have created 32,946 direct jobs in the last three years viz. 2019, 2020 and 2021. The year-wise distribution is as under:
