Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) the salient features of the Public Distribution System (PDS);
- (b) the steps taken by the Government for digitalization of fair price shops for making food and public distribution system more transparent in all the States of the Country;
- (c) the number of PDS shops which are computerised across the country, State/UT-wise including Gujarat;
- (d) whether any time limit has been fixed for completion of computerisation of PDS across the country and if so, the details thereof, State/UT-wise including Gujarat; and
- (e) whether any technical snags are being faced in implementation of digitalization of public distribution system and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

The Targeted Public Distribution System (TPDS) is operated under the (a) to (e): provisions of the National Food Security Act, 2013 (NFSA) for distributing highly subsidised foodgrains every month to around 80 Crore beneficiaries, nearly two-third of the country's population as per the Census of 2011. This Department, in association with all States/UTs, has implemented a scheme on 'End-to-End Computerization of Targeted Public Distribution System (TPDS) Operations' including automation of Fair Price Shops (FPSs) to bring transparency and efficiency in the allocation and distribution of highly subsidised foodgrains to beneficiaries covered under National Food Security Act, 2013 (NFSA). So far, nearly 5.33 Lakh out of total 5.34 Lakh FPSs in the country (including Gujarat) have been automated by installing ePoS devices. Also, ration cards/beneficiaries database have been completely digitized in all States/UTs, transparency portal and online grievance rederessal facility/Toll-free number have been implemented in all States/UTs, online allocation has been implemented in all States/UTs (except UTs of Chandigarh and Puducherry which have adopted DBT Cash Transfer scheme) and supply chain has been computerized in 31 States/UTs. The government has made necessary provisions to ensure that no genuine beneficiary denied the entitled quota of foodgrains in the event of the occurrence of technical snags like biometric failure, lack of connectivity etc. At present about 94% (average of last 3 months) of foodgrains are distributed through biometric (Aadhaar) authentication.
