- (a) the details of the skill development programmes started for initiating the skill building of labourers in the textile industry sector;
- (b) the details of the number of textile training centres operating in the States of Karnataka and Maharashtra;
- (c) the number of beneficiaries including those in the States of Karnataka and Maharashtra under Integrated Skill Development Scheme (ISDS) and SAMARTH during the last three years and the current year; and
- (d) the amount allocated and utilized in Karnataka and Maharashtra for the above programme?

उत्तर ANSWER वस्त्र राज्य मंत्री (**श्रीमती दर्शना जरदोश**) THE MINISTER OF STATE FOR TEXTILES (SMT. DARSHANA JARDOSH)

(a): With a view to address the critical gap of skilled manpower in the textile industry through industry-oriented training programmes, Ministry of Textiles introduced Integrated Skill Development Scheme (ISDS) as a pilot scheme in the last two years of 11th Five Year Plan (FYP). The scheme was scaled up as main phase during 12th FYP with an allocation of Rs. 1,900 crore. ISDS was operational upto 2017-18.

In further continuation, Ministry of Textiles has expanded the skill development programme namely, Samarth- Scheme for Capacity Building in Textile Sector, in alignment with overall skilling framework prescribed by Ministry of Skill Development and Entrepreneurship. The Scheme initially approved for implementation from 2017-18 to 2019-20 has been extended upto 31.03.2024. The scheme provides industry oriented entry level and upskilling programmes for origanized sector (excluding spinning & weaving) and skill upgradation programmes for weavers/artisans in traditional textile sector.
