#### **FTTH CONNECTIONS**

### 2455. DR. PRITAM GOPINATHRAO MUNDE: SHRI RAHUL RAMESH SHEWALE: SHRI GIRISH BHALCHANDRA BAPAT: SHRI CHANDRA SEKHAR SAHU:

Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether the process for releasing FTTH Connections in the BharatNet Phase-I districts of the States have been completed;
- (b) if so, the details and the status thereof, State-wise;
- (c) the details of funds so far allocated, released and utilised under BharatNet project in the country;
- (d) whether BSNL has prepared any action plan for Maharashtra and Odisha;
- (e) if so, the details thereof along with the number of villages proposed to be connected with internet service;
- (f) whether the State Governments of Maharashtra and Odisha has requested funds under special assistance to be utillised under BharatNet Phase II; and
- (g) if so, the details in this regard along with the action so far taken by the Union Government thereon?

# ANSWER MINISTER OF STATE FOR COMMUNICATIONS (SHRI DEVUSINH CHAUHAN)

- (a) & (b) BharatNet project is implemented in a phased manner to provide broadband connectivity to all Gram Panchayats (GPs) of the country. Bharat Sanchar Nigam Limited (BSNL) undertakes the task of providing Fiber to the Home (FTTH) connections in Gram Panchayats through Channel Partners. The State/UT-wise details of FTTH connections provided under BharatNet Phase-I is given in **Annexure**.
- (c) As on 31.10.2022, Rs. 36,502.41 crore has been allocated /released/disbursed from Universal Service Obligation Fund (USOF) under BharatNet project.
- (d) & (e) Bharat Sanchar Nigam Limited (BSNL) has developed Franchise Management System (FMS) for onboarding the Franchises / Local Entrepreneurs / Revenue Share Partners for providing FTTH connections using BharatNet also in the country, including Maharashtra and Odisha. The BharatNet Phase-II is implemented in Maharashtra and Odisha by the State Government under State-led model, which is also responsible for its utilization. The scope of BharatNet to provide broadband connectivity is extended to all inhabited villages beyond GPs in the country, including Maharashtra and Odisha.
- (f) & (g) Under Part-V (Optical Fibre Cable) of the Scheme for Special Assistance to States for Capital Investment for the year 2022-23, the State Government of Maharashtra and Odisha have submitted proposal amounting to Rs. 611.37 Crore and Rs. 326.69 Crore respectively. Department of Telecommunications submitted these proposals along with recommendation to Department of Expenditure. As of now, Department of Expenditure has approved the capital expenditure on the Optical Fibre Cable Network amounting to Rs.286 Crore for the State of Maharashtra.
