- (b) if so, the details of these pending railway works route/location-wise;**
- (c) the main reasons for delay in completing the above works; and**
- (d) the time by which the aforesaid pending railway works are likely to be completed, route-wise?**

JADHAV AND SHRI SHA.BRA.DR.JAI SIDDESHWAR SHIVACHARYA MAHASWAMIJI TO BE ANSWERED IN LOK SABHA ON 21.12.2022 REGARDING CONSTRUCTION OF ROB_s/RUB_s IN KARNATAKA AND MAHARASHTRA

(a) to (d): At present, total 1603 Road Over Bridges (ROBs) and 2666 Road Under Bridges (RUBs) are pending in the country. Out of which 460 ROBs and 323 RUBs are in progress and 1143 ROBs and 2343 RUBs work are at various stages of planning & estimation, approaches, land acquisition, removal of encroachments, etc. However, status of the ROB/RUB at Koppal Constituency, Kalaburagi and Solapur are as under:

The problem is faced in construction of approaches because of many factors such as fixing the alignment of approaches, land acquisition, removal of encroachments, finalization of General Arrangement Drawing (GAD), acceptance and sanction of estimate, allocation of requisite funds and decided the executing agency in State portion by State Government etc. Therefore, it is not feasible to fix definite timelines for completion of these ROB/RUBs.
