Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of budget allocated under Smart Cities Mission (SCM) during the last five years, State-wise;
- (b) the names of the cities identified under SCM in Maharashtra, phase-wise;
- (c) the details of the districts and Parliamentary Constituencies of Maharashtra for which essential funds have been allocated under the said mission to develop these as smart cities;
- (d) the details of the funds allocated and utilised so far for the said purpose;
- (e) whether the work of smart city project in the said identified cities is likely to be completed on time;
- (f) if so, the details thereof and if not, the reasons therefor; and
- (g) the steps being taken by the Government to expedite the works along with the progress report of the above said works?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) to (g): Government of India launched the Smart Cities Mission (SCM) on 25 June 2015. 100 Smart Cities have been selected through 4 rounds of competition from January 2016 to June 2018. As per SCM Guidelines, Central Government will provide financial support to the extent of ₹ 48,000 crore over five years to the 100 Smart Cities i.e., on an average ₹ 100 crore per city per year. An equal amount on a matching basis will be contributed by the State Government/Urban Local Body (ULB). The cities of Aurangabad, Kalyan-Dombivali, Nagpur, Nashik, Pimpri-Chinchwad, Pune, Solapur and Thane were selected for development as Smart Cities in Maharashtra. Round-wise list of 100 Smart Cities, including Smart Cities in Maharashtra, is given in Annexure-I.

As on 2 December 2022, under SCM, Government of India has released ₹ 34,675 crore of which ₹ 30,418 crore (88%) has been utilized. Work orders have been issued in 7,738 projects worth ₹ 1,81,112 crore of which 4,987 projects worth ₹ 92,439 crore have been completed.

The details of funds released by the Government of India under SCM for the Smart Cities of Maharashtra and utilization thereof and the status of their projects is given below:-

Implementation of SCM at the city level is done by the SPV created for the purpose. In addition, Smart City Advisory Forums (SCAFs) comprising of District Collector, MP(s), MLA(s), Mayor, CEO of SPV, local youths, technical experts etc. has been constituted in each Smart City to advise and enable collaboration among various local stakeholders. At the State level, State level High Powered Steering Committee (HPSC) chaired by the Chief Secretary has been established to guide Mission implementation. At the national level, implementation of SCM is being monitored by an Apex Committee headed by Secretary, Ministry of Housing and Urban Affairs (MoHUA).

The period of implementation of SCM has been extended upto June 2023 and all Smart Cities, including Smart Cities in Maharashtra, are expected to complete their projects within the stipulated time.
