2587. SHRI DULAL CHANDRA GOSWAMI:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the details of Retail Outlets (ROs), Gas Agencies and CNG Pumps reserved for SCs/STs in each division of Oil Marketing Companies (OMCs) in the country including Bihar, State/UT-wise:
- (b) the details of responses received, rejected and not received from SCs/STs against advertisements of OMCs at each reserved location, State/UT-wise;
- (c) the location-wise list of ROs, Gas Agencies and CNG Pumps commissioned and operational under the category of 'Company Owned and Company Operated' (COCO); and
- (d) the list of COCO, ROs, Gas Agencies and CNG Pumps contracted/sub-letted to SCs/STs and others as on date?

(a)&(b) Public Sector Oil Marketing Companies (OMCs) have implemented new "Dealership Selection Guidelines" for Retail Outlets w.e.f. 24.11.2018 and "Unified Guidelines for Selection of LPG Distributorships" w.e.f. 23.6.2016. Both these guidelines inter alia, have a provision of 22.5% reservation for SCs/STs and 27% reservation for OBCs in allotment of retail outlet dealerships and LPG Distributorships. Within SC/ST, OBC & Open categories, there is reservation also for Defence personnel, Para Military Personnel/Central/State Govt. and Central/State PSU employees, Physically Handicapped Persons, Outstanding Sports Persons and Freedom Fighters.

State/UT wise details of locations advertised, response received, nil response (not received) and rejected (not found suitable) from SCs/STs against advertisement released by PSU OMCs for retail outlets (petrol pumps) in 2018 and LPG distributorships in 2016 are given in **Annexure-1** & **Annexure-2** respectively.

Establishment of CNG stations is part of development of City Gas Distribution (CGD) Network and the same is carried out by the entities authorized by Petroleum and Natural Gas Regulatory Board (PNGRB), which do not reserve allocation by category.

(c)&(d) Company Owned Company Operated Outlets (COCOs) are Retail Outlets (ROs) owned & operated by PSU OMCs and are identified considering factors such as strategic location, brand image creation, potential training centers for dealers and dealership staff, piloting of new retail initiatives, etc. The day-to-day operation of such ROs is under the regular supervision of the PSU OMC itself. PSU OMCs appoint Service Provider to provide manpower and service for fuel dispensing and other related activities and maintenance of the COCO ROs for fixed period. As the COCO ROs are owned and operated by PSU OMCs themselves, these COCO ROs are not sub-let to others.

The State/UT wise details of permanent COCO retail outlets being operated by PSU OMCs as on 01.10.2022 are given in **Annexure-3** and geographical area-wise details of CNG stations established under COCO category are given in **Annexure-4**.
