STATUS OF PMAY-URBAN

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the present status of Pradhan Mantri Awas Yojana Urban (PMAY-U) in Solapur of Maharashtra and Kalaburagi and Koppal of Karnataka;
- (b) the number of beneficiaries who have been identified and allotted houses in the said cities of thesaid States;
- (c) the number of persons who are yet to be allotted houses under PMAY-U; and
- (d) the time by which the allotment/target is likely to be done/achieved?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) to (c)Ministry of Housing and Urban Affairs (MoHUA), under the vision of 'Housing for All', is supplementing the efforts of States/

UTs by providing central assistance under Pradhan Mantri Awas Yojana- Urban (PMAY-U) for construction of houses for all eligible urban families/ beneficiaries since 25.06.2015. There are no fixed targets under PMAY-U Scheme. Based on the demand, State Government prepares project proposals and afterapproval of projects by State Level Sanctioning and Monitoring Committee (SLSMC) submits to the Ministry for sanctioning by Central Monitoring and Sanctioning Committee (CSMC).

The present status including number of houses sanctioned, grounded and completed under PMAY-U in Solapur of Maharashtra and Kalaburagi and Koppal of Karnataka is annexed as Annexure.

(d) The completion of projects generally takes 12-36 months under different verticals of Scheme. States/ UTs are required to adhere to the timeline as mentioned in Detailed Project Reports for completion of project. The States/UTs have been advised to expedite the construction of sanctioned houses so that all houses are completed within the stipulated period.
