PRE-MATRIC SCHOLARSHIPS

2683. ADV. A.M. ARIFF: SHRI ASADUDDIN OWAISI:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether it is true that the Government has decided to limit the pre-matric scholarship to students of Minority Communities of class 9 and 10 only from ongoing academic year 2022-23 and if so, the details thereof and the reasons therefor;
- (b) whether the Government has taken note of the fact that limiting the scholarship will seriously affect the prospects of thousands of students from economically backward households belonging to Minority Communities especially Muslims in continuing their studies;
- (c) if so, the details thereof and the action taken thereon;
- (d) whether the Government intends to continue with the existing system of providing pre-matric scholarship to all students studying in class 1 to 10 and if not, the reasons therefor;
- (e) the details of the number of applications received, rejected and approved of pre-matric scholarships during the year 2022-23, State and UTwise; and
- (f) whether students in Madarsas holding recognition for providing formal education are covered by the scheme and will continue to be covered and if so, the details thereof?

ANSWER

THE MINISTER OF MINORITY AFFAIRS (SHRIMATI SMRITI ZUBIN IRANI)

(a) to (d): Ministry of Minority Affairs implements Pre-Matric Scholarship Scheme for students from weaker economic background belonging to the 6 notified minority communities, namely, Buddhist, Christian, Jain, Muslim, Parsi and Sikh. The coverage under the scheme has been modified from 2022-23 and made applicable for classes IX and X only as the Right to Education (RTE) Act, 2009 provides for free and compulsory elementary education (classes I to VIII) to each and every child. This modification has also been done to harmonize the Scheme with the identical Scholarship Schemes implemented by Ministry of Social Justice & Empowerment and Ministry of Tribal Affairs.

(e): The State/ UT-wise details of the number of verified applications received, rejected and yet to be verified by States/ UTs under Pre-Matric Scholarship Scheme during 2022-23 is annexed. Applications are approved for payment after verification process is over and merit list is drawn.

(f): Yes, Sir.
