#### **Pure Water in Rural Areas**

#### †2715. SHRI CHANDRA PRAKASH JOSHI:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether the Government has prepared any plan to provide pure water to the rural areas of the country during the next five years;
- (b) if so, the details of the plan to provide pure water to all households in Rajasthan, district-wise; and
- (c) the details of the number of households in Rajasthan which have been supplied pure water in Rajasthan so far, district-wise?

#### **ANSWER**

### THE MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a)to (c) To make provision of tap water supply to every rural household across the country by 2024, Government of India, is implementing Jal Jeevan Mission (JJM) since August 2019, in partnership with States.

At the time of announcement of Jal Jeevan Mission on 15<sup>th</sup> August 2019, 3.23 Crore (17%) rural households were reported to have tap water connections. So far, around 7.52 Crore (38%) additional households have been provided with tap water connections. Thus, as on 19.12.2022, out of 19.36 Crore rural households in the country, more than 10.75 Crore (55.54%) households are reported to have tap water supply in their homes.

Similarly, at the time of announcement of Jal Jeevan Mission, 11.74 lakh (11.10%) rural households were reported to have tap water connections in the State of Rajasthan. So far, around 19.70lakh (18.62%) additional households have been provided with tap water connections. Thus, as on 19.12.2022, out of 105.78 lakh rural households in Rajasthan, more than 31.44 (29.72%) households are reported to have tap water supply in their homes. The State Government has planned to cover the remaining 74.34 lakh rural households by 2024. District-wise details of tap water connections provided so far are **annexed**.
