NO. 334. SHRI GNANATHIRAVIAM S.:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- a) whether the Government has decided that urban poor getting assistance for construction of their own houses under various Government schemes;
- b) if so, the number of urban poor provided houses under various schemes in the country during each of the last three years and the current year, State-wise along with the total funds incurred thereon;
- c) the number of houses sanctioned for urban poor in the country as on date, State/UT-wise;
- d) the details of the projects under which these houses have been sanctioned; and
- e) the total outlay involved therein?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a): 'Land' and 'Colonization' are State subjects. Therefore, respective State/ Union Territories (UTs) have to address the housing needs of its population. However, Ministry of Housing and Urban Affairs, through various interventions, is supplementing the efforts of States/ UTs for construction of houses for all eligible families/ beneficiaries in urban areas of the country. The Ministry is providing admissible central assistance under four verticals namely i) "In-situ" Slum Redevelopment ii) Affordable Housing in Partnership iii) Affordable Housing through Credit Linked Subsidy Scheme and iv) Beneficiary-Led Individual house construction of Pradhan Mantri Awas Yojana- Urban (PMAY-U) since25.06.2015 under the vision of 'Housing for All'.
