Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of the major projects and special programmes being run by the Government in health sector, State/UT-wise;
- (b) whether the Government proposes to set up any sickle cell centre for the treatment of fatal diseases in the tribal-dominated area of Amravati, Maharashtra and if so, the details thereof;
- (c) whether there is any provision of Mobile Medical Unit under National Health Mission and if so, the number of such Mobile Medical Units functioning across the country along with the funds allocated for the same district, State/UT-wise; and
- (d) whether the Government has rolled out any plan to provide doctors as per the demand in the States/UTs and if so, the details thereof along with the number of States/UTs which have received the benefits of the said Scheme till date?

ANSWER

MINISTER OF STATE FOR HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

- (a) The Ministry of Health and Family Welfare through various Centrally Sponsored Schemes and Central Sector Schemes supplements the efforts of the States/UTs in the healthcare sector. The major Schemes/Programmes implemented through the States/UTs are as under:
 - i) National Health Mission (NHM)
 - ii) Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY)
 - iii) Pradhan Mantri Ayushman Bharat Health Infrastructure Mission (PM-ABHIM)
 - iv) Establishment of New Medical Colleges

- v) National Progaramme of Prevention and Control of Cancer, Diabetes, CVDs and Stroke (NPCDCS)
- vi) National Vector Borne Disease Control Programme (NVBDCP)
- vii) Pradhan Mantri Swasthya Suraksha Yojana (PMSSY)

Under PMSSY, 16 major projects for new AIIMS in various States of the country i.e. Uttar Pradesh, Maharashtra, Andhra Pradesh, West Bengal, Punjab, Himachal Pradesh, Assam, Jharkhand, Gujarat, Telangana, Jammu & Kashmir, Bihar, Haryana and Tamil Nadu are running.

- (b) Integrated Centre for Haemophilia and Hemoglobinopathy (ICHH) is already established / functional at Civil Hospital, Amravati for management of Thalassemia, Sickle Cell & Haemophilia which all are genetic disorders. Dharni and Chikhaldara are tribal dominated Talukas of Amravati District. Treatment of Sickle cell crisis (fatal) is available at Sub District Hospital, Dharni and Rural hospital, Chikhaldara. The State Government has not proposed to set up any new Sickle Cell centre. Sickle Cell disease control program is conducted in 21 Districts of Maharashtra including Amravati District and in this program, services provided are screening, confirmation of diagnosis, treatment, prevention of disease transmission, counselling, card distribution and pre-natal diagnosis regarding sickle cell at free of cost.
- (c) The State/UT wise approvals towards National Mobile Medical Units (MMUs) under NHM from Financial Year 2019-20 to 2021-22 is given at Annexure.
- (d) The Government of India has taken many steps to increase the availability of doctors in the country which include:
 - i. Centrally Sponsored Scheme for establishment of new medical college by upgrading district/ referral hospital under which 157 new medical colleges have been approved and 93 are already functional.
 - ii. Centrally Sponsored Scheme for strengthening/ upgradation of existing State Government/Central Government Medical Colleges to increase MBBS and PG seats.
 - iii. Central Sector Scheme for upgradation of Government Medical Colleges by construction of Super Specialty Blocks. A total of 75 projects have been approved and 58 have been completed.
 - iv. Under Central Sector Scheme for setting up of new AIIMS, 22 AIIMS have been approved. Undergraduate courses have started in 19 AIIMS.
 - v. Relaxation in the norms for setting up of Medical College in terms of requirement for faculty, staff, bed strength and other infrastructure.
 - vi. DNB qualification has been recognized for appointment as faculty to take care of shortage of faculty.
 - vii. Enhancement of age limit for appointment/ extension/ re-employment against posts of teachers/dean/principal/ director in medical colleges upto 70 years.
 - viii. The tenure of Senior Residency for appointment of Assistant Professor have reduced from three years to one year.
 - ix. To enhance healthcare facilities at District/ Rural level and to address the issue of shortage of specialists in the country, the Government has approved District Residency Program where second/third year PG students of medical colleges are to be posted in the District Hospitals for a period of three months.
