FUNDS SANCTIONED UNDER NRHM AND NUHM

617. COL. RAJYAVARDHAN RATHORE:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to State:

- (a) the details of the funds sanctioned and utilized under National Rural and Urban Health Mission, during each of the last three years, State/UT-wise;
- (b) the details of the funds allocated for Rajasthan under National Digital Health Mission, district-wise; and
- (c) whether the Government has assessed the quality of healthcare services in the country especially in the State of Rajasthan and if so, the details and the outcome thereof?

- (a) to (c): Details of funds released and utilized under National Rural Health Mission (NRHM) and National Urban Health Mission (NUHM) during the last three years, State/UT-Wise is given at Annexure-I and II respectively.

The quality of healthcare services has been assessed in the State of Rajasthan under the ambit of the National Quality Assurance Programme (Kayakalp, NQAS, LaQshya). The progress made so far under Kayakalp, NQAS, and LaQshya is given as follows:-

- I. Status of Kayakalp:** A total of 721 public health facilities, comprising 121 DHs, 12 SDHs, 158 CHCs, 362 PHCs, 132 UPHCs, and 45 Health and Wellness Centres, were assessed and awarded in FY 2021–22. A peer assessment of 3595 public health facilities has completed for the current FY 2022–2023 including 36 DHs, 1 Satellite Hospital, 14 SDHs, 523 CHCs, 1550 PHCs, 198 UPHCs, 1238 Health & Wellness Centres, and 35 City Dispensaries.

II. Status of NQAS Certification: As on 30th November 2022, a total of 56 healthcare facilities were assessed and nationally NQAS Certified facilities. It includes 6 DHs, 2 SDHs, 18 CHCs, 22 PHCs, 8 UPHCs, and 19 are state certified including 2 DHs, 6 CHCs, 8 PHCs & 3 UPHCs.

III. Status of LaQshya Certification (Labor Room & Maternity OT) as on 30th November 2022:

- As on 30th November 2022, a total of 40 LR including 3 Medical Colleges, 26 DHs, 3S DHs & 8 CHCs are Nationally assessed and LaQshya certified.
- Similarly, 25 Maternity OTs including 1 Medical College, 19 DHs, 3 SDHs & 2 CHCs are Nationally assessed and LaQshya certified.

IV. SUMAN (Surakshit Matritva Aashwasan):

- With that goal of ensuring guaranteed “guaranteed service delivery.’,MoHFW has launched "SUMAN - Surakshit Matritva Aashwasan," a multifaceted and integrated policy strategy that brings together all existing programs under one roof.
- In Rajasthan, 400 are SUMAN notified facilities, out of which 43 are state-level NQAS certified and 19 are national-level NQAS certified.

National Digital Health Mission (NDHM) is now known as the Ayushman Bharat Digital Mission (ABDM). The funds earmarked to the State of Rajasthan is as follows:
