DEATH CASES OF COVID-19 IN KERALA

Will the **MINISTER OF HEALTH & FAMILY WELFARE** be pleased to state:

- a) whether the Government has maintained any data on the deaths during the pandemic owing to COVID-19, if so, the details thereof, State/UT-wise;
- b) the details of number of deaths due to COVID-19 in Kerala before the verdict of Supreme Court regarding the criteria fixed to register COVID deaths in the country including Kerala in this regard;
- c) the details of the compensation given to the deceased person/their family who have died due to COVID-19 in Kerala along with the reasons for the delay in disbursing such compensation to them;
- d) whether the Government has issued any directions to the States to expedite the disbursement of compensation for family of the deceased; and
- e) if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH & FAMILY WELFARE (DR BHARATI PRAVIN PAWAR)

(a) to (e): Ministry of Health & Family Welfare maintains data on COVID-19 deaths as reported by States. A total of 5,30,633 deaths due to COVID-19 have been reported by States/UTs in the country as on 6th December 2022. Details of deaths reported by States/UTs is at **Annexure.**

Hon'ble Supreme Court had issued orders regarding the criteria fixed to register Covid-19 deaths on 30th June 2021. The total deaths as reported by the State of Kerala as on 30th June 2021 was 13093.

As per Hon'ble Supreme Court's directions, NDMA has issued guidelines for Ex-gratia assistance to next of kin of the deceased by Covid-19 on 11th September 2021. States are accordingly sanctioning Ex-Gratia to the eligible families.

The guidelines issued by NDMA has recommended States/UTs to settle all claims within thirty days of submission of required documents, subject to cause of death certified as COVID-19.
