## TRAINING UNDER PMKVY

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

(a) the objectives and steps taken for effective implementation of Pradhan Mantri Kaushal Vikas Yojana (PMKVY) and the current status of its implementation;

(b) whether unemployed/untrained youth were supposed to received training and thereafter provided employment under Pradhan Mantri Kaushal Vikas Yojana (PMKVY), State-wise including Tamil Nadu;

(c) the number of beneficiaries along with the targets set by the Government and achievements made under the said scheme including potential beneficiaries who have established self-employment, State-wise including Maharashtra, Tamil Nadu, Dadra and Nagar Haveli and Daman and Diu;

(d) the State-wise number of PMKVY centres set up in the country including Maharashtra, Tamil Nadu, Dadra and Nagar Haveli and Daman and Diu;

(e) the details of funds allocated and spent by the Government under PMKVY, Statewise especially Dadra and Nagar Haveli and Daman and Diu, and Tamil Nadu during each of the last three years;

(f) whether the Government has also formulated any mechanism to ensure the employability for those skilled workers after training under PMKVY, if so, the details thereof, State-wise including Tamil Nadu; and

(g) whether there has been any impact or pressure of Covid Pandemic on PMKVY and if so, the details thereof?

#### ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(a) Ministry of Skill Development and Entrepreneurship (MSDE) is implementing Pradhan Mantri Kaushal Vikas Yojana (PMKVY) with an objective to deliver skills to youth of the country through Short Term Training (STT) and Recognition of Prior Learning (RPL).

To ensure effective implementation of PMKVY, the life cycle of training process of candidates (enrolment – training – assessment – certification - placement) is tracked on real-time basis through the Skill India Portal (SIP), which is linked with Aadhaar-enabled biometric attendance. Training Centres (TCs) are being monitored effectively through various methodologies such as self-audit reporting, call validations, surprise visits, etc.Further, in order to improve the monitoring under PMKVY, District Skill Committee (DSC) have been involved and entrusted with the monitoring under PMKVY 3.0. DSC acts as an on-ground monitoring agency for conducting inspection of TCs.

(b) Under PMKVY, placement opportunities have been provided to STT certified candidates, while RPL is not linked with placements as it recognizes the existing skills of candidate. The State/UT-wise including State of Tamil Nadu candidates trained, certified and reported placed (including self employed) under STT and candidates oriented and certified under RPL, since inception i.e. 2015 upto 30.09.2022, are given at *Annexure I*.

(c) The phase-wise target of the scheme and achievement thereon, since inception i.e. 2015 upto 30.09.2022 is given below:

State/UT-wise candidates trained/oriented, certified and reported placed including self-employmed under PMKVY including Maharashtra, Tamil Nadu and Dadra& Nagar Haveli and Daman & Diu is given at *Annexure I*.

(d) Under PMKVY, short term training is being imparted in empanelled TCs including model and aspirational training centres known as Pradhan Mantri Kaushal Kendra (PMKK). The State/UT-wise number of PMKVY TCs including PMKKs imparted training under PMKVY including Maharashtra, Tamil Nadu, and Dadra & Nagar Haveli and Daman & Diu, since inception i.e. 2015 upto 30.09.2022, are given at *Column (a) of Annexure II.* 

(e) PMKVY has two components, namely, Central component implemented through National Skill Development Corporation (NSDC) and State component implemented through State Skill Development Missions (SSDMs) of the State/UT. The State-wise funds utilized under Central component and funds disbursed under State component under PMKVY including Dadra & Nagar Haveli and Daman & Diu and Tamil Nadu, in last three years, i.e., FY 2019-22, is given at *Column (b) of Annexure II.* 

(f) Under PMKVY, various initiatives are taken to enhance placement of the STTcertified candidates such as organization of Rozgar Melas with the support of Sector Skill Councils; placement linked release of last tranche funds to the TCs; requirement to have dedicated mentorship-cum-placement cells at TCs / Training Providers (TPs) for industry linkage and placement of candidates; incentive to TCs @ Rs. 3000 per trainee if he or she is retained in employment for 12 months; post placement support of Rs. 1,500 per month per trainee for special areas/special groups; one-time placement travel cost upto maximum of Rs. 4,500 per candidate; implementation of employer-led training model; etc.

The State/UT-wise including Tamil Nadu candidates reported placed under PMKVY, since inception i.e., 2015 upto 30.09.2022, are given at *Annexure I*.

(g) Yes, Sir. The COVID-19 pandemic has caused disruptions in economy, livelihood and labour market. The skill ecosystem was also impacted due to COVID-19 induced lockdown.

In order to mitigate the impact of COVID-19 pandemic and to restore the skilling activities, MSDE has taken various initiatives under the skill ecosystem such as introduction of On-line skill training through eSkill India portal and Bharat Skill portal, Customized Crash Course Programme for COVID Warriors, Special programme for training of reverse migrants under PMKVY in six States, COVID Allowance to training centres, Operation and Maintenance of Pressure Swing Absorption (PSA) Oxygen Plants, etc.
