Under National Clean Air Programme (NCAP), the following national level committees have been set up for coordination, monitoring and evaluation of progress of action plans by various stakeholders to improve air quality in 131 cities:

- (i) Apex Committee
- (ii) Steering Committee
- (iii) Monitoring Committee
- (iv) Implementation Committee

1 Apex Committee, 3 Steering Committee, 5 Monitoring Committee and 6 Implementation Committee meetings have been convened during the period of January, 2021 - October 2022.
