Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the details of the Public Sector Undertakings (PSUs) contributing under their Corporate Social Responsibility (CSR) in Bihar especially in Jahanabad, Arwal and Gaya regions during the last three years; and**
- (b) the details of the funds spent by these PSUs under CSR during the said period?**

(a) & (b): The broad framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. The CSR framework is disclosure based and CSR mandated companies are required to file details of CSR activities annually in the MCA21 registry. All data related to CSR filed by companies in MCA21 registry are available in public domain and can be accessed at www.csr.gov.in. On the basis of annual filings made by companies in the MCA21 registry, the CSR spent by Public Sector Undertakings (PSUs) in the State of Bihar during the last three financial years (FY) 2018-19, 2019-20 and 2020-21 respectively is as follows:
