## OPENING OF NEW KENDRIYA VIDYALAYAS IN UTTAR PRADESH

### †895. SHRI R.K. SINGH PATEL:

Will the Minister of EDUCATION be pleased to state:

- (a) the details of Kendriya Vidyalayas proposed to be constructed in Uttar Pradesh, district-wise especially in Bundelkhand;
- (b) whether the Government proposes to open new Kendriya Vidyalayas in Banda and Chitrakoot districts; and
- (c) if so, the details thereof at the time by which they will be ready; and
- (d) if not, the reasons therefor?

# MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SMT. ANNPURNA DEVI)

(a) The following Kendriya Vidyalayas (KVs) in the State of Uttar Pradesh, including KV Sumerpur, district Hamirpur in Bundelkhand Region of Uttar Pradesh are at pre-construction / construction stages:-

(b) to (d) Kendriya Vidyalaya Sangathan (KVS) has informed that a new KV in Banda District has been sanctioned in the year 2018 but could not be made functional as the State Government has not provided the requisite land and suitable rent free temporary building as per the norms. KV Chitrakoot has been established and made functional in the year 2011-12 in the temporary accommodation provided by the sponsoring authority.

Construction of permanent buildings for KVs is a continuous process, which depends upon identification of suitable land, completion of lease formalities in favour of KVS by the sponsoring authorities, submission of drawings / estimates by construction agency, availability of funds and requisite approvals etc. No definite time frame can be given in this regard.
