## Deep Sea Fishing Scheme

### 935. SHRI MADDILA GURUMOORTHY:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING मत्स्यपालन, पश्पालन और डेयरी मंत्री be pleased to state:

- (a) the details of the progress made under the Deep Sea Fishing Scheme which was launched to provide for 2,000 deep sea fishing boats in place of trawlers, while aiming to put an end to disputes arising between India and Sri Lanka;
- (b) whether the Government has undertaken any assessment regarding impact of this scheme, State-wise; and
- (c) if so, the details thereof and if not, the reasons therefor?

#### **ANSWER**

### MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

### (SHRI PARSHOTTAM RUPALA)

(a) to (c): The Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying under the erstwhile Centrally Sponsored Scheme (CSS) on "Blue Revolution: Integrated Development and Management of Fisheries" that was implemented during the period from 2015-16 to 2019-20 had approved proposals of various Coastal State Governments/UT Administrations for acquisition of a total 918 Deep-Sea Fishing vessels for traditional fishermen at a total cost of Rs. 73,440 lakh and central assistance of Rs. 31209.51 lakh released to various States and UTs for this purpose. This includes a total of 750 deep sea fishing vessels approved for Tamil Nadu to replace trawlers operating in Palk Bay as to decongest Palk Bay and to enable these boats to go to deep sea.

Under the ongoing scheme Pradhan Mantri Matsya Sampada Yojana (PMMSY), support for acquisition of Deep-Sea Fishing vessels for traditional fishermen, to promote diversification of fishing efforts and Deep Sea fishing in Indian Exclusive Economic Zone (EEZ) has been continued. During the last two financial years (2020-21 and 2021-22) and current year (2022-23), the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying has approved the proposals of various coastal States and UTs and sanctioned an amount of Rs.14332.00 lakh to coastal States/UTs for procurement of a total of 426 Deep Sea Fishing Vessels with total cost of Rs. 51120 lakh and Central share of Rs. 14332 lakh for this purpose under the PMMSY.

State-wise details of the deep sea fishing vessels approved under the above said scheme are furnished at Annexure. Since the scheme is still ongoing, as such no impact studies have been done.
