STORAGE AND PROCESSING OF FRUITS AND VEGETABLES

966. SHRI VIVEK NARAYAN SHEJWALKAR

Will the Minister of **FOOD PROCESSING INDUSTRIES** be pleased to state:

- (a) the details of the schemes being run by the Government for storage and processing of fruits and vegetables;
- (b) whether the Government has provided assistance to food processing units and food parks in various districts of Madhya Pradesh and if so, the details thereof;
- (c) the number of food parks set up in Madhya Pradesh till date; and
- (d) whether the Union Government has received any proposal from the Government of Madhya Pradesh to set up a new food park and if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI PRAHLAD SINGH PATEL)

(a): The Ministry of Food Processing Industries (MoFPI) has been implementing an umbrella scheme- Pradhan Mantri Kisan Sampada Yojana (PMKSY) since 2017-18 across the country. PMKSY is a comprehensive package of sub-schemes, aimed at creation of modern infrastructure with efficient supply chain management from farm gate to retail outlet. Under the following sub-schemes, financial support in the form of grants-in-aid is provided for setting up of projects including the components for storage and processing of fruits and vegetables:

- (i) Integrated Cold Chain and Value Addition Infrastructure (Cold Chain)
- (ii) Creation/Expansion of Food Processing and Preservation Capacities (CEFPPC)
- (iii) Creation of Infrastructure Development for Agro Processing Cluster (APC)
- (iv) Operation Greens(OG) - Long Term Interventions
- (v) Mega Food Parks Scheme (MFP) (discontinued w.e.f. 01.04.2021)
- (vi) Creation of Backward and Forward Linkages (CBFL) (discontinued w.e.f. 01.04.2021)

(b) & (c): The details of food processing projects including two mega food parks assisted by MoFPI in various districts of Madhya Pradesh State as on 30.11.2022 are given at **Annexure**.

(d): Mega Food Parks Scheme has been discontinued w.e.f. 01.04.2021 and also no proposal has been received from the Government of Madhya Pradesh for setting up of a new food park.
