State/UT-wise and year-wise details of total number of authorized hospital admissions under the scheme since its inception are at Annexure.

As on 02nd February 2023, a total number of 4.34 crore hospital admissions worth Rs. 51,749.40 crore have been authorized under the scheme. Therefore, average per capita expenditure is Rs. 11,924 under the scheme.

The scheme was implemented in the State of West Bengal from 23.09.2018 to 10.01.2019. An amount of Rs. 31.28 crore was released as Central share to the State Government. The State Government withdrew from the scheme on 10.01.2019. A total number of 1,11,89,727 families are eligible to avail benefits under the scheme.
