Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the details of regions where Jan Shikshan Sansthan(JSS) scheme has contributed to people's education, State-wise particularly in Maharashtra, Uttar Pradesh and Madhya Pradesh;
- (b) whether the Government has appointed the trainers under the said scheme through the process and the eligibility criteria for the same, and if so, the details thereof; and
- (c) the number of JSS centres functioning in the country, State-wise along with number of people trained, assessed and certified in such centres in Jharkhand including Hazaribagh and Ramgarh?

REGARDING 'JAN SHIKSHAN SANSTHAN (JSS)'**

a) The salient features of the Jan Shikshan Sansthan scheme are:

- i. Imparting skill development training in non-formal mode to non-literates, neo-literates, persons having rudimentary level of education and school drop-outs upto 12th standard in the age-group of 15-45 (age relaxation is given to divyang and other deserving cases, especially, women) in rural and urban low-income areas
- ii. Providing skill training to the beneficiaries at their doorsteps with minimum infrastructure and resources.
- iii. Improving the quality of life of the target group belonging to disadvantaged sections of the society especially women, SC, ST, and minority by increasing their family income through local demand skilling.
- iv. Creating awareness on health, personal hygiene, education, financial literacy, environment, women issues and national/international important days with the help of local community.

At present, 288 Jan Shikshan Sansthans (JSSs) are functioning in 26 States and 7 UTs. The list of 288 functional Jan Shikshan Sansthans, including 21 JSSs in Maharashtra, 47 JSSs in Uttar Pradesh and 27 JSSs in Madhya Pradesh is given at **Annexure-I**.

- b) No, Sir. JSSs are hiring the services of the trainers locally, as per the qualifications and experience given in the job roles approved by NCVET.
- c) The State/UT-wise number of JSSs and the number of beneficiaries trained, assessed, and certified during FY 2021-22, under the Scheme of JSS across the country is given at **Annexure-II**. The number of beneficiaries trained, assessed and certified by the JSSs in Hazaribagh and Ramgarh districts of Jharkhand is given below:
