BUDGETARY ALLOCATION UNDER PMKVY

***167. SHRI CHANDRA SEKHAR SAHU:**
SHRI GIRISH BHALCHANDRA BAPAT:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the details of the budgetary allocation made by the Government under the Pradhan Mantri Kaushal Vikas Yojana Phase-3 (PMKVY 3.0), State-wise particularly for Odisha and Maharashtra;
- (b) the details of the funds actually released and utilised there under in 2021-22 and 2022-23 so far, State-wise particularly to Odisha and Maharashtra;
- (c) the aggregate cost incurred by the Government under the PMKVY Phase 3 (PMKVY 3.0) in placing one candidate under the said scheme in the country particularly in Odisha and Maharashtra;
- (d) whether the aggregate cost incurred was greater than the expected cost for placement; and
- (e) if so, the details thereof and the reasons therefore?

REGARDING BUDGETARY ALLOCATION UNDER PMKVY**

(a) Ministry of Skill Development and Entrepreneurship (MSDE) launched the Pradhan Mantri Kaushal Vikas Yojana (PMKVY 3.0) on 15.01.2021 to deliver skills to youth of the country to make them employable for better livelihood, with an outlay of Rs. 948.90 crore. PMKVY 3.0 has two components, namely, Centrally Sponsored Centrally Managed (CSCM) known as Central component which was implemented through National Skill Development Corporation (NSDC) and Centrally Sponsored State Managed (CSSM) known as State component which was implemented through State Skill Development Missions (SSDMs) of the State/UT. Out of the total outlay of the scheme, 75%, i.e., Rs. 712 Cr. (approx.) was for Central component and 25%, i.e., Rs. 237 Cr. (approx) was for State component. Under Central component of PMKVY, Rs. 644.27 crore has been disbursed to NSDC for the implementation of scheme through training centres across the country covering all States. The State-wise allocation of funds, including the states of Odisha and Maharashtra under CSSMPMKVY 3.0, is given at **Annexure I**.

(b) The State-wise fund utilised under CSCM component and fund released and utilized under CSSM component of PMKVY 3.0 during the Financial Year 2021-22 and 2022-23 as on 28.02.2023 are given at **Annexure II**.

(c) to (e) The overall training cost paid to Training Providers (TPs) is inclusive of cost elements as laid down under Common Norms, which includes placement expenses. The placement expenses are not separately identified.
